



## CHECKLIST GI ENDOSCOPIC PROCEDURES

- ☐ Directions to the facility
- ☐ Preparation Instructions
- ☐ Laxative, or prescription
- ☐ I understand that I will be sedated for the procedure, and that I will not be able to drink alcohol, drive, sign legal documents, or work with machinery on the day of my procedure.
- ☐ Since I cannot drive, I will make arrangements for someone to drive me to and from the procedure, and to escort me to and from the facility and the car. **A bus or taxi is not acceptable.**
- ☐ The driver or the responsible individual will remain in the waiting area, or on the hospital grounds, where they may be reached by a pager that will be provided.
- ☐ If my procedure is performed at the Olympia Multi-specialty Clinic Ambulatory Procedure Center, I am aware that physicians of the Olympia Multi-specialty Clinic own the facility and that if I prefer, I can have my procedure performed at another facility in the area.
- ☐ I recognize that kidney or heart disease may require antibiotics or a special type of preparation, and I have discussed this with the nurses or doctor.
- ☐ If having a colonoscopy and a polyp is removed, do not go to remote areas for two weeks after procedure.
- ☐ If I cancel or reschedule my procedure less than 72 hours prior to the scheduled day, I may be charged a \$100.00 cancellation fee.
- ☐ I have been informed and understand the instructions given.
- ☐ I have been offered Advanced Directive Information.
- ☐ I have received a copy of the Patient Rights information and responsibilities.
